Separate sealed bids for the Phase I Replacement of Approximately 2,500 Linear Feet of 18-Inch Wastewater Line for the City of Bishopville in Lee County, South Carolina will be received at the Offices of the City of Bishopville located at 135 East Church Street in Bishopville, South Carolina 29010 until **2:30 P.M.** on **May 3, 2018** and then publically opened and read aloud at 135 East Church Street in Bishopville, South Carolina 29010, City Hall Chambers.

The work to be completed as a part of this project consists of providing all required materials, equipment, all related appurtenances, and labor necessary to complete the Phase I Replacement of Approximately 2,500 Linear Feet of 18-Inch Wastewater Line for the City of Bishopville in Lee County, South Carolina.

This project is being funded in whole or in part by the Community Development Block Grant Program (CDBG). All federal CDBG requirements will apply to the contract. All contractors and subcontractors are required to be registered in the Federal System for Award Management (SAM). Bidders on this work will be required to comply with the President's Executive Order No. 11246 & Order No. 11375 which prohibits discrimination in employment regarding race, creed, color, sex, or national origin. Bidders must comply with Title VI of the Civil Rights Act of 1964, the Davis-Bacon Act, the Anti-Kickback Act, the Contract Work Hours and Safety Standards Act, and 40 CFR 33.240. Bidders must also make positive efforts to use small and minority-owned business and to offer employment, training and contracting opportunities in accordance with Section 3 of the Housing and Urban Development Act of 1968. Attention of bidders is particularly called to the requirements as to conditions of employment to be observed and minimum wage rates to be paid under the contract.
